- 5 Purchaser may release the payment after successful supply of kits within mutual agreed time.
- 6 The supplier will have to supply the whole kit as well as any items of the kit on demand.
- 7 NCERT in no way will be responsible for delay in supply payments.
- 8 NCERT reserves the right to reject the Kit/Kit items, if found unsuitable & not conforming to the specifications. The rejected items, if any, shall have to be taken back by the supplier and the same will be replaced by good quality at the Supplier's cost & no payment will be made for rejected items. The Demand Draft should be in favour of 'Secretary, NCERT' and payable at New Delhi.
- 3 Warrantee/Guarantee of the sold items/kits should be for the period of one year from the date of supply.
- 4 NCERT reserves the right to decide Parallel Rate Contract (PRC) and reserves right to inform the firms about lowest rates and the firms with lowest rates and ask them to reduce their rates without tax as per L-1 rate of that particular kit in accordance with GFR. The firms which will match the price without tax with the L-1 will be empanelled with NCERT and the institutions/individuals/schools and those who want to purchase the kits from empanelled firms may choose the firm as per their convenience and as per their state rules considering freight, taxes and other charges into account.
- 5 The council reserves right to terminate the panel/ empanelment of any of the empanelled firm at any time before expiry of the empanelment period without assigning any reason.
- 6 The council reserves right to seek performance report from clients/users who purchase Science and mathematics kits from empanelled firms. In case performance report is not satisfactory, empanelment will be cancelled and action will be taken as per clause 5.10, Also after sales service and warrantee / guarantee parameters will also be taken into consideration.
- 7 The supplier will have to supply the individual kit as well as individual kit items on demand.
- 8 NCERT reserves the right to reject the Kit/Kit items, if found unsuitable & not conforming to the specifications. The rejected items, if any, shall have to be taken back & the same will be replaced by good quality at the Supplier's cost & no payment will be made for rejected items. The supplied items inspected & if the same are found in good condition, then only the same will be accepted by NCERT.
- 9 If any complaint received by demanding institutions in respect of quality, after sales, service etc penalty of maximum of 10% order value would be imposed by NCERT and in case of failed timely delivery Liquidity damages will be imposed.
- 10 If at any time, there shall arise any dispute, difference or question with regard to the interpretation or meaning of any terms & condition, prices etc. of this EOI or in respect of rights, duties & liabilities of the parties hereto or in any way touching or arising out of these presents or otherwise in relation to the present EOI, then every such dispute, difference, doubt or question (except the decision whereof is herein expressly provided for) shall be referred to arbitration of the sole arbitration to be appointed by Director, NCERT under Indian Arbitration & Conciliation Act 1996 or any statutory modification re-enactments thereof and rules made there under for the time being in force shall apply to such arbitration. The venue of arbitration shall be the place from where the contract is finalized.
- 11 The purchaser requires the bidder to follow the laws against any fraud and corruption in force in India, namely Prevention of Corruption Act 1988 amended from time to till date.
