**NOTIFICATION**  
**POLICY REGARDING 2 YEARS' DURATION**  
**E.T.T. DIPLOMA COURSE ADMISSIONS**

Admissions to Elementary Teachers Training Diploma Course in Government and Private institutions authorized, as per National Council for Teacher Education (Recognition Norms & Procedure) Regulations, 2009, through on-line Counselling on combined merit based centralized admission process to be undertaken by Director General School Education and Director State Council of Educational Research and Training, (SCERT) Punjab Vidhya Bhawan, Punjab School Education Board, Block-E, 6<sup>th</sup> Floor, Mohali - 160062.

**Academic Session:**

Academic Session 2013-15 will commence on 15<sup>th</sup> November, 2013 to November, 2015.

**Minimum Educational Qualification:**

Senior Secondary (PLUS 2) or Equivalent with minimum 50% marks of General Category & 45% marks for S.C./S.T. Category. No candidate with Reappear/Compartment/Result Later etc. shall be eligible to apply.

**Proposed Intake:**

Humanities, Science, Commerce and Vocational Stream as per combined merit, provided that no single stream shall exceed a maximum of ¼ of seats meant for any institution.

**Merit Criteria:**

As per NCTE rules, the candidates of General Category who have obtained atleast 50% marks in 10+2 or equivalent will be eligible. Five percent relaxation in marks will be given to SC/ST students. The admission will be on merit basis. No additional marks will be given for Higher Education.

**Language:** Candidates should have passed Punjabi upto matric level.

**Additional Condition:** To ensure high quality standards, any candidate who has not passes every subject in Class X Examination shall not be eligible to apply.

**Maximum Age:** General Category Candidate-27 years on the date of application with Five years age relaxation for SC/ST candidates.

**Reservation:** For all institutions, reservation shall apply as per the Punjab Government Policy guidelines.

**Tie:** In case of a tie in any eventuality, the following criteria of preference criteria shall be adopted.

- (iii) Higher comparative merit, and if merit is equal.
- (iv) Higher age

**Domicile & Bonafide Residence:** Punjab Government's policy guidelines shall be applicable.

**Application Processing Fee:**

Rs. 400 for General Category

Rs. 200 for Reserved Category (S.C./S.T.)

**Counseling, Scrutiny & Verification:** A committee headed by Director General School Education, and consisting of Director SCERT and Principals of DIETs/Private Institution concerned shall scrutinize the documents of the candidates having declared a particular district as their first choice and allocate them to respective institutions of the District as per their *inter se* merit. After one round of District Based Allocations, unfilled seats in a district will be allocated to surplus candidates from other districts on the basis of his/her first preference, followed by second preference, and so on and overall combined merit out of the remaining candidates. Three rounds of counseling will be held for fulfillment of the admission process.

**Filling of ETT Seats in Private Institutions:** As per policy, 60% of seats in private institution will be filled through combined merit by the SCERT and remaining 40% seats of management quota will be filled by the concerned institutions subject to minimum qualification mentioned in this notification. The concerned institutions will take the permission from SCERT regarding the admission process for the 40% management seats.

**Fees:** The private self financed E.T.T. Institution will charge fees as determined by the fee fixation committee constituted by the Department of School Education Govt. of Punjab.

**Admission No guarantee to Government Employment:** Admission to government or privately run ETT Diploma course or passing of the said course shall not confer any right to employment upon the recipient of such a diploma in the employment of the state or elsewhere.

**No Migration:** There shall be no migration of admitted candidates from one institute to another under any circumstances.

**No Mid Term Filling of Seats:** There shall be no mid-term filling up of vacancies caused due to any reason whatsoever.

**False Documents:** The admission of any candidate, found to have submitted false, forged, fabricated or tempered documents, shall be liable to be cancelled at any stage, besides registering a criminal case against him and barring him for re-admission in the E.T.T. Course for a period of three years.


