Objectives.

- To provide affordable and accessible Diploma in Elementary Education by opening required number of Government/Private D.El.Ed. (ETT) Institutes.
- 2. To ensure quality training in D.El.Ed. (ETT) by an effective and regular monitoring.
- 3. To ensure a steady flow of skilled teachers in different subjects of school education.
- 4. Fo raise the quality and quantity of teacher education as per the National Curriculum Frame Work in order to implement RTE Act in the State of Puniah.

Activities

- To provide affordable and assessiable Diploma in Elementary Education by opening required sumber of Government/Private D.El.Ed. (ETT) Institutes:
 - 1. Issuing No Objection Certificate (NOC) for opening new D.El.Ed. (ETT) Institutes
 - Any Agency/Society/Institute/Trust/Association/body eligible to open D.El.Ed. (ETT) Institutes
 as per NCTE guidelines may apply to NCTE in the Performa as decided by NCTE from time.

The applicant will simultaneously send the copy of the above mentioned application to The Director SCERT, Punjab.

- The Director SCERT, Punjab may approve or reject the application as per the requirement of such D.El.Ed. (ETT) Institutes in Punjab as assessed by the High Level Committee already constituted for this purpose, —vide Government of Punjab notification No. 11/327/09-3Edu-1/424. dated 5th/6th November, 2009.
- This committee will assess such requirement after every two years.
- As per the requirement of D.El.Ed. (ETT) Institutes in Punjab as assessed by the High Level Committee, the Director SCERT, Punjab will get the institute inspected to ensure the fulfillment of all conditions as laid down by NCTE and/or Government of Punjab from time to time and inform the NCTE regarding issuance or rejection of NOC within 45 days from receiving intimation
- The Director S.C.E.R.T., Punjab shall have the power to formulate and implement methodology, fee structure and procedure for inspection and granting NOC to be sent to NCTE for opening D.El.Ed. (ETT) Institutes in Punjab

Giving Affiliation to D.El.Ed. (ETT) Institutes duly recognized by NCTE:

- After getting recognition from NCTE, the institute will apply for affiliation within 30 days to the Director SCERT Punjab, Chandigarh in the Performa duly prescribed by SCERT Punjab.
- If any institute fails to apply in stipulated period their case for affiliation will not be considered for that session.
- If NCTE recognizes any institute without or against the recommendations of the Director SCERT, Punjab then Director SCERT, Punjab will take-up the case with NCTE for reconsideration of recognition.
- Affiliation will be given to the eligible institutes subject to fulfillment of all terms and conditions as laid down by NCTE and/or SCERT Punjab from time to time.
- The Director SCERT, Punjab snall have the power to make and implement methodology, fee structure and procedure for affiliation of D.El.Ed. (ETT) Institutes in Punjab.
- All private D.El.Ed. (ETT) Institutes duly recognized by NCTE before the notification of this pericy shall be affiliated by SCERT. Punjab subject to application submitted by these Private D.El.Ed. (ETT) Institutes within 30 days from notification and fulfillment of all terms and conditions as laid down by NCTE and/or SCERT Punjab from time to time.

Hi. Fee Structure for D.El.Ed. (ETT) Institutes duly recognized by NCTE:

- Private D.El.Ed. (ETT) Institute will charge fee from students as decided by the SCERT Punjab.
 Chandigarh from time to time. However, the fee shall be decided by a fee fixation committee notified by the State Government in the department of School Education.
- To ensure quality training in D.El.Ed. (ETT) by an effective and regular monitoring.

1. Monitoring of D.ELEd. (ETT) Institutes duly recognized by NCTE:

- * To provide effective monitoring every institute will adopt Self Disclosure Framework to provide on line information in the form as decided by NCTE and/or SCERT Purjab.
- Annual inspections and surprise inspections will be conducted by the committee constituted by the Punjab Government and/or Director SCERT Punjab, Chandigarh.
- Every D.El.Ed. (ETT) Institute will develop grievance redressal system to hear the complaints of the students and will solve their problems.
- The Director SCERT, Punjab shall have the power te formulate and implement methodology, fee structure and procedure for monitoring D.El.Ed. (ETT) Institutes in Punjab.

II. To ensure a steady flow of skilled teachers in different subjects of school education:

Admission shall be made on merit as per the policy of the State Government.

- The seats in the private D.El.Ed. (ETT) Institutes duly recognized by NC 25 and affiliated with SCERT lingary chandigarh shall be divided in the ratio 60 and when management quota for which the institutes shall be free to admit students through an appropriate nd fair examination system duly approved by the SCERT Punjability advance.
- For the rest of 60% seats, the admission shall be made through Common Entrance Test to be conducted every year by SCERT Punjab Chandigath or any other selection process as per the policy of the State Government. The reservation policy as notified by the department of welfare shall be applicable on these seats.
- If above mentioned 60% of seats are not being filled up to Common and the common of seats through their own above mentioner. titues will be allowed to fill up vacant
- · No private D.El.Ed. (ETT) Institutes shall refuse to admit students as a part of any special scheme or measure initiated by the Government of Punjab for admitting any special category.
- Date of common entrance test will be announced by the SCERT/Punjab Government before
- After getting recognition from NCTE, private D.El.Ed. (ETT) Institutes will have to apply for the affiliation one month prior to the last date of application for Common Entrance Test
- The Director SCERT. Punjab shall have the power to formulate and implement methodology, fee structure and procedure for Common Entrance Test for admission into D.F.L.Ed. (ETT) Institutes

To raise the quality and quantity of teacher education as per the National Curriculum Frame Work in order to implement RTE Act in the State of Punjab.

Curriculum and examination of D.El.Ed. (ETT) Institutes duly recognized by NCTE:

- Each private D.El.Ed. (ETT) Institutes will follow the curriculum as framed by SCERT/NCTE
- Each semester examination will be conducted by SCERT, Punjab after completion of mandatory
- The Director SCERT, Punjab shall have the power to make and implement methodology, fee structure and procedure conducting semester examination in D.El.Ed. (ETT) Institutes in Punjab.
- All residual powers including amending this policy and directing D.El.Ed. (E. T) Institutes shall remain with the Government of Punjab in the Department of School Education.
- SCERT Punjab, Chandigarh shall be the nodal agency for implementation of this policy.

Regarding issuing N.O.C for grant of recognition for starting D.El.Ed. Course.

Kindly refer to your DO. No. 51-4/2014/NCTE/N&S (Vol.1) dated 9th April, 2015 on the subject cited above.

In order to examine the feasibility/requirement of opening of more Private Self Financed D.El.Ed. (Formely ETT) College, the State of Punjab had constituted a committee vide order no. 12/01/2011-2ES/3138-46 dated 13.08.2013. The committee took stock of requirement and availability of seats of D.El.Ed. Course in the State for the sessions 2012-14 and observed that only 1480 seats could be filled out of the total 4080 seats. The situation did not improve with the admissions for the session 2013-15. In this backdrop, the committee decided that there is no requirement of more colleges at least for the next two sessions i.e session 2015-17 and 2016-18. The decision of the committee was conveyed to you vide this office's letter no. 9/105-12 D (3) dated 24-09-2014 requiesting thereby not to consider the already received applications, nor demand fresh applications to open new Self Financed D.El.Ed. Colleges/increase the seats in the existing colleges for the session 2015-17 and 2016-18.

This decision of the Government of Punjab has also been intimated to you vide our letter no. 9/105-12D(3) dated 20-01-2015.

In the light of the decision of the State govt, cited above we can not issue NOC to the course cited in the subject.
