



Sub:- Medical Reimbursement to Govt. Employees/Pensioners and their dependent who are getting insurance at their own level.

Sir,

I am directed to invite your attention to letter No.12/193/94-5HB5/5251-54, dated 13.2.1995 and letter No. 12/23/2003-5HB5/13195 dt.22.7.2004

2. The Government has considered the matter regarding the reimbursement of medical bills of Punjab Government employees/pensioners and their dependents who have subscribed to medical insurance policies on their own and thus are eligible for reimbursement by the insurance companies. It has been decided with the approval of the competent authority that the reimbursement of medical expenditure from both the sources, namely insurance agency and Government, may be claimed, subject to the condition that employees/pensioners will first claim insurance from insurance company and there after submit the medical bills to the Government, which will reimburse the difference between the total amount of the bills and the payment made by the insurance company, with condition that the payment done by the Government will not exceed the admissible amount as per Government rates.

3 It is clarified that these instructions will be implemented from the date of the issue of these instructions i.e from 23.5.2013. These instructions will also be implemented in those cases, where D.H.S. give its approval for reimbursement after 23.5.2013.
