

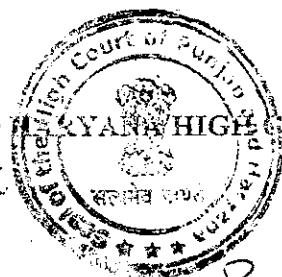

An issue of public importance has been raised in this petition which qualifies the service matter as well. The issue has in the past received attention of the Supreme Court in Election Commission of India v. Saint Mary's School and others; (2008) 2 SCC 390. The Court directed the Government that its teaching staff must only be put on duties of electoral revisions and election work on holidays and non-teaching days and the teachers should not ordinarily be put on such duties on teaching days and within teaching hours as that will be subversive to the cause of education. The petitioners in this case are teachers from Fazilka area of Punjab and complain that they have been put on election duty as Booth Level Officers by Punjab Government to work 24 x 7 at the cost of class room work.

Notice of motion, returnable by 8.10.2015.

Process has only to respondent No.1.

On the asking of the Court, Mr. Inqilab Nagpal, Assistant Advocate General, Punjab accepts notice on behalf of respondents No.2 to 5 and waives service on them. Mr. Khurana to supply 5 sets of the paperbook to Mr. Nagpal during the course of the day. Mr. Nagpal prays for and is granted three weeks time to file reply with advance copy to the counsel opposite.

Notice re: interim directions.

In the meantime, Punjab Government is directed to address

... comply with the directions of the Supreme Court in Education
Commission of the New Central Board's School [supra] and restrict Booth
Board Officers work for the teachers only to be performed on holidays and
after school hours and better still, to deploy persons from other than the
Education Department by scraping pan from other local department in the
Districts from where human resources can be enlisted. The Government
must remember that all civil and judicial authorities have to act in aid of
the Supreme Court under Article 144 of the Constitution of India.
