

Subject:- e-Gazette-Printing and Uploading of Gazette Notifications on Website.

In line with Digital India initiative and automation of various services under the IWDMS, a joint vision of the Department of Printing & Stationery and Department of Governance Reforms is to achieve a state of publishing e-Gazette with no paper printing.

A phased approach has been envisaged to attain the desired state. To start with the automation of communication channel between Administrative Departments and Printing & Stationery Department and the processes involving publishing and uploading of documents on Punjab Government Website are being taken up.

For this purpose, Login users & password would be issued to the Departments/Organizations of Punjab Government, other stakeholders and various other designated entities which send notifications pertaining to Acts, Ordinances, Rules, Amendments, Instructions etc. to Printing & Stationery Department for printing. Under the new system, only the authorized users would be able to send the notifications to the Printing & Stationery Department through online mode for publishing and uploading on the Punjab Government Website.

It is therefore, requested that nodal officers be appointed for sending the notifications to Printing & Stationery Department. Login ID's in IWDMS would

be required for offices other than the Secretariat. The form for new ID creation is enclosed
