Subject: Implementation of Punjab Government Employees & Pensioners Health Insurance Scheme.

The State Government has issued notification No. 21/28/12-5HB5/268, dated 20.10.2015, for implementing the above-mentioned scheme and Punjab Health Systems Corporation has been declared as implementing agency. In this regard, following clarifications are given;

- As per Para-4 of the notification, it has been specified that no reimbursement will be available for the treatment in Punjab and Chandigarh where cashless treatment is available. However, it is clarified that the bills pertaining to Government hospitals like; PGIMER Chandigarh, GMCH Sector 32, Chandigarh and General Hospital Sector 16, Chandigarh will be reimbursed to the employees on submission of their bills to the Insurance Company. The bills can be sent for reimbursement to the Oriental Insurance Company C/o MDIndia Healthcare Services (TPA) Pvt. Ltd., Maxpro Info Park, D-38, 1<sup>st</sup> Floor, Industrial Area, Phase-1, Mohali (Punjab) - 160055.
- As per the Para-3 of the notification, it has been specified that medicines for chronic diseases will also be made available on cashless basis from designated stores and hospitals in every district and block. Till this system is put in place, the chronic disease reimbursement claims of previous month can be submitted in all the Suvudha Centres of the District, special counter in Main and Mini Secretariat, Oriental Insurance Company Office, Quiet Office No. 15, Sector 35-A, Chandigarh or can be sent on Speed Post Registered post, or through courier to MDIndia Healthcare Services Pvt. Ltd. office address which is mentioned above in the first five working days of the month. For example; the bills of January-16 has been received in the five working days of February-16 and likewise for February-16, in the first five working days of March-16 and so on.
