However, as per State Government instructions (No. 7/204/2012-4FP1/66 dated 15.01.2015), during the probation period, they will only be eligible for fixed emoluments, i.e. equivalent to the minimum of the Pay band. During the probation period, they would not be entitled to any grade pay, annual increments or any other allowances, except TA. As per Punjab Cabinet decision (30.4.2016), the probation period of all fresh appointees would be 3 years.

5. SELECTION PROCESS

The recruitment shall be conducted at the centres as may be decided depending upon the number of applicants. Candidates will be informed about the Recruitment Centre via SMS & email and the details about the centres will also be uploaded on the recruitment website.

The Recruitment Board shall conduct the Substance Abuse (Drug Addiction) Test (SAT), Physical Screening Test (PST) and the Physical measurement Test (PMT) of a candidate shall be conducted on a single day.

Every candidate will be required to undergo a Substance Abuse (Drug Addiction) Test at the Recruitment Centre Every candidate will be required to undergo a Substance Abuse (**Drug Addiction**) Test at the Recruitment Centre before the conduct of the Physical Screening Test (PST) and Physical Measurement Test (PMT). The Test shall be conducted under the supervision of officials of the Health Department/recognized Medical University/Institute. Only those candidates who clear/pass the Substance Abuse Test shall be eligible for appearing in the PST/PMT.

The candidates who are declared clear in the SAT shall be required to appear in the PST, which shall be of a qualifying nature and shall comprise of the Race, Rope Climbing (un-assisted), Standing Broad Jump for all candidates except Ex-Serviceman. 7. INTERVIEW-CUM-PERSONALITY TEST (03 Marks)

From amongst the candidates who qualify the SAT, Physical Screening Test and Physical Measurement Test, the Chairman Recruitment Board will draw up a **Preliminary Merit List**, on the basis of the Marks obtained by the candidates in the **Height measurement** (15 marks), **Educational Qualification** (10 marks) and **Additional Marks** as given above (02 marks). The total score will be out of maximum 27 marks.


