The CEO shall forward only such proposal(s) that cleared by the aforesaid Screening Committee to ECI along with his/her comments immediately. Hence, all departments of the State may be advised not to forward any reference direct to the Commission. Further, the concerned departments of the Govt should not send original file to the CEOs office and only a self-contained reference be sent through the Screening Committee.
