Sub: Counting of service of employees/retired employees of State Autonomous Bodies/Boards and Corporations for the purpose of pension and pensionary benefits in Government Departments.

Sir/Madam,

I am directed to invite a reference to instructions issued by the Government of Punjab, Department of Finance vide letter No. 4/90/2010-1FPPC/734820/1 dated 18.4.2016 on the subject cited above whereby the previous service rendered by an employee in the State Autonomous Bodies/Boards and Corporations before his/her joining Government Department is to be counted for the pension/pensionary benefits as a special one time measure.

It is clarified that these instructions were issued for the employees of such State Autonomous Bodies/Boards and Corporations which were wound up by the government and the employees were absorbed in Government Departments and they subsequently became eligible for pension under old pension scheme.

These instructions, are, however, not applicable to the employees of State Autonomous Bodies/Boards and Corporations who joined Government Departments for any other reason.
