As per Prime Minister's order no.1908-PMO/78 dated 12.9.1978 (copy enclosed) addressed to Union Home Minister and Chief Ministers of all States, whenever a Member of the Commission visits any State for discharge of his/her functions in accordance with NCM Act, 1992, they are to be given the courtesies and facilities of Minister of State. Further, Chairman of the Commission enjoys the status equivalent to Union Cabinet Minister.

2. However, despite such instructions, Chairman and Members of the Commission are facing difficulties during their official visits and are denied the courtesies and facilities which should be given to them in accordance with above instructions. This matter was also taken up by my predecessor.

3. I would request you to issue necessary instructions to the concerned State Government authorities to comply with the above instructions and extend the courtesies and facilities listed in the Annexure to Chairman and Members whenever they make an official visit to your State for discharging their duties.

3. Prime Minister's D.O. on Commission's status: 1978

- (No. 1908-PMO/78 of 12.9.1978 addressed to Union Home Minister & Chief Ministers of all States)

- We have appointed two separate Commissions to safeguard the interests of (i) Minorities, whether based on religion or language, and (ii) Scheduled Castes and Scheduled Tribes. Copies of the relevant Notifications are attached for your perusal. We have also introduced a Bill in Parliament to amend the provisions of Articles 340 and 350-B with a view to conferring on these two Commissions Constitutional sanctions.
- 2. To enable these Commissions to discharge their functions efficiently, you will agree that we should give them the required status and importance and extend to them fullest cooperation at the Central and State levels. The Chairperson and the Members of the Commissions would be visiting different States in the course of their duties. I would be grateful if you would issue necessary instructions to ensure that when such visits take place, the Chairperson and the Members are given the courtesies and facilities which are extended to Central Ministers, etc.
- 3. It might be advisable for you to have a general discussion with them, but when detailed discussions on any aspect are required it would be useful if the Minister concerned or some other senior officer who can speak authoritatively on behalf of the State Government holds discussions with the Commission. Wherever rules in your State permit, they may also be treated as State guests in the matter of accommodation, transport etc.
- 4. I have made these suggestions in the hope that these arrangements would ensure proper atmosphere of cooperation and harmony between the two Commissions and the State Governments.

Protocol, courtesies and facilities to the Chairperson and Members of the National Commission for Minorities

The Chairperson and Members of the National Commission for Minorities frequently visits different states in order to discharge their functions efficiently. Hence it is in the fitness of things that they should be given required status and importance and extended fullest cooperation at the central as well state levels. As per Prime Minister Office D.O. No. 1908 – PMO / 78 dated 12.9.1978 the Chairperson and the Members should be given the courtesies and facilities which are extended to Central Ministers, etc.

2. In order to ensure smooth visit of Chairperson and Members and a fruitful discussion with the targeted audience, the following courtesies and facilities should be ensured for Shri Sunil Singhi :

To be treated as state guest during visits to states;

(b) All courtesies and facilities as available to a Central Minister should be extended, including arrangements for suitable accommodation, AC vehicle, protocol/Liaison officer, PSO, Pilot / escort should be made.

(c) I should be informed well in advance by e-mail / fax about the arrangements made and the name and mobile number of all contacts / persons at the place of visit; and

(d) It should be ensured that the state government make arrangements for proper hall / auditoria with dais / sound system with water etc. for the Jan Sunwai programme. The state commission along with local Minority Officer / District Administration should invariably coordinate not only such visits but also make arrangements during the public meets events.
