Subject: Defending the Civil Appeals in the various courts on behalf of the Punjab state.

Sir,

I am to state that according to the present procedure on receipt of Sanction from the controlling Authority, instructions to defend the interest of the State of Punjab are issued by this Deptt. to the District Attorneys. In some cases, the Civil suits are decided in favour of the State, but the private parties prefer appeals before the appellate court in the Distt. It is a settled law that appeal is a continuation of the proceedings of the civil suits. Sometimes, if fresh instructions are issued by the Controlling Authority in order to defend the interest of the State in the appellate court, it leads to delay. It has, therefore been decided that if a civil suit is decided against the State and an appeal is preferred by a Private party in the appellate court in the District, if instructions to defend the interest of the State had been issued by this department to the Distt. Attorney no fresh instructions to defend the appeal in the appellate court are required to be issued. The Distt. Attorneys are being directed to appear in the appellate court in such cases if an officer

of the department approaches the District Attorneys and also gives in writing to protect the interest of the State in the appellate court. Similarly in a civil suit some time an application 39 R 1&2 of CPC for the grant of ad-interim injunction is filed. The trial court decides the application in favour of the State but the private party prefers an appeal before the Distt. Judge. In such cases also, the Distt. Attorney will protect the interest of the State in the appellate court, if, so approached by the department as mentioned above subject to the condition that instructions to defend the civil suit had been issued by this department. It has also been decided that if an execution application is moved by a private party, the Distt. Attorney will defend the interest of the case without getting fresh instructions issued by us in accordance with the procedure enumerated above. If, a civil suit is decided in favour of the State with costs and an execution application for the recovery of the amount or costs is to be moved, the Department can approach the Distt. Attorney without our instructions to file an execution application in the executing court. These instructions are being sissued to streamline the working of the Law Officers in the field and also to ensure that the interest of the State in the various courts is defended in the best possible manner.
