Vide this office order No 16/3-2017 Estt-2(6), Estt-3(4), dated 12-12-2017, a combined seniority of Masters and Mistresses of various subjects working in the Department of School Education was circulated. The said seniority list was challenged by Sh. Kanwaljit Singh and others by filing CWP No. 3491 of 2018. The said writ petition came up for hearing on hearing on 15.2.2018, when while issuing notice of motion for 19.7.2018, this Hon'ble Court was pleased to pass the following interim order:-

"Contends that the petitioners have been promoted on the basis of their seniority vide order dated 17-05-2012 (Annexure P-6). The case of the petitioners is covered by the judgment passed by Hon'ble Division Bench of this Court in Neelam Rani Vs State of Punjab reported in 2010 (2) RSJ 70 (P&H) (DB).

Notice of Motion for 19-07-2018.

The operation and effect of the final seniority list dated 12.12.2017 (Annexure P-12) shall remain stayed till further orders".

2. In order to consider the contentions put forth by the petitioners in the above said writ petition, to remove technical deficiencies alleged to have been pointed out by the petitioners and all other relevant factors, a Committee consisting of senior officers and officials having sufficient expertise in the matter has already been constituted vide office order No 16/3-2017 Estt-2(6), Estt-3(4), dated 08-06-2018. The Committee shall make its suitable recommendations within a period of one month positively. Therefore, seniority list dated 12.12.2017 of Masters and Mistresses is hereby ordered to be withdrawn. The fresh seniority of Masters and Mistresses of various subjects working in the Department of School Education shall be re-casted and issued in due course of time after taking into consideration of all relevant factors.
