**Subject: Regarding simplification of disbursement of pensionary benefits in respect of Old Pension Scheme in view of the decision taken in the meeting of Council of Ministers held on 18.03.2017**

Sir/Madam,

I am directed to invite your attention to the instructions issue by the Department of Finance, vide its letter No. 3/50/2017-3FPPC/1156618 dated 01.02.2018 whereby the procedure with regard to the release of pensionary benefits was simplified in view of the decision of the cabinet meeting dated 18.03.2017. The Department of Finance has also issued the following instructions in the recent pass to implement the order dated 22.10.2013 passed by the Hon'ble High Court in CWP No. 25733 of 2012 and order dated 30.09.2016 in CWP No. 2866 of 2014:-

2. As per the instructions/clarifications as enlisted in the above table, the revision of pension cases is to be authorized by the Accountant General Punjab. However, as per the instructions dated 01.02.2018, under para 2(iii), the revision of pension/Family pension/gratuity is sanctioned at the level of Pension Sanctioning Authority and an endorsement of the same is to be sent to Accountant General Punjab & DTO/Bank. Accordingly a confusion has arisen with regard to the appropriate authority to revise the pension/family pension/gratuity.

3. The matter has been reconsidered by the Department of Finance in consultation with AG (A&E), Punjab and it is clarified as under:-

a) The instructions as enlisted in table above i.e category 1 to 4 be implemented as such, i.e. revision of pension cases is to be authorized by AG, Punjab;

b) The partial modification of instructions dated 01.02.2018, the following procedure shall henceforth be adopted for the pensionary benefits:-

(i) Since the service rendered by an employee beyond the date of retirement on superannuation does not count for the qualifying service for pension, all the pensionary benefits (except leave encashment and Group Insurance Scheme) shall be determined/approved as per the existing rules contained in Chapter IX, Punjab Civil Services Rules, Vol-II before the date of superannuation, irrespective of whether the employee may seek extension in service beyond the date of superannuation or not.

The column in Pension Payment Order (PPO) regarding "Date of Commencement of Pension" be left blank by the office of Accountant General (A&E), Punjab at the time of issuance of PPO since the date of actual retirement of the employee may not be known to the O/o Accountant General (A&E), Punjab. This column shall be filled by the concerned District Treasury Officer on the certification of the Pension Sanctioning Authority regarding the date of actual retirement of the employee.

The pension and pensionary benefits shall, however, become payable only from the following day of the actual date of retirement on normal superannuation or after the extended period of service, as the case may be.

(ii) It has also been decided that henceforth, the payment of Death cum Retirement Gratuity (DCRG) shall be made by the Treasury/Bank as in the cases of pension and commutation of pension to curtail the delays. In case, any recoverable government due from the employee comes to the notice of government after the submission of the pension case to the Accountant General, Punjab, the same shall be affected from the leave encashment payable to the pensioner at the level of Pension Sanctioning Authority.





- (iii) It has also been decided that except category 1 to 4 above the concerned Pension Sanctioning Authority shall sanction the revision of pension/family pension and/ or the amount of DCRG and issue authority at its own level purely on provisional basis as per the Performa enclosed. Thereafter, the Pension Sanctioning Authority shall forward all such cases where it has revised pension/family pension/DCRG on provisional basis to the Accountant General (A&E), Punjab for issuing final authority. The concerned District Treasury Officer shall grant the benefit of revision of pensionary benefits on the basis of such provisional sanction issued by the Pension Sanctioning Authority. Pension Sanctioning Authority shall be responsible for any excess payment to the pensioner/family pensioner on the basis of provisional authority issued at its level & any payment, made in excess, shall be recovered from the Pension Sanctioning Authority & its subordinate staff. Pension Sanctioning Authority shall ensure correctness of the payment with the final authority issued by the O/o Accountant General (A&E), Punjab.
- (iv) The O/o Accountant General (A&E), Punjab shall finalize the pension revision cases **received in their office as on the date of issuance of these instructions** at their level. The remaining cases, which are either in the pipeline or the cases which are with the Pension Sanctioning Authorities and have not yet been sent to the O/o AG (A&E) shall be decided by the Pension Sanctioning Authorities in accordance with the procedure as laid down above.
- (v) A copy of the following documents shall be ensured to be sent by the concerned authorities to the O/o Accountant General (A&E), Punjab for updation of their record:
- a) Copy of provisional authority for revision of rate of pension/family pension and/or the amount of DCRG issued by the Pension Sanctioning Authority to the office of Accountant General (A&E), Punjab and to the concerned District Treasury Officer (Specimen attached as Annexure); and
  - b) Copy of sanction of the revised basic pay and also of change in qualifying service, if any, issued by the Competent Authority due to which revision of pensionary benefits has been necessitated.

4. **These instructions shall be applicable from the date of issue of this letter.**

holder of PPO/No. is drawing Basic Pension at the rate of Rs. per month with effect from from your Treasury. His/Her Rate of Basic Pension has been revised to Rs. (Rupees) w.c.f. Out of the Revised Pension of Rs. has been already commuted. So, the Pensioner will get a Net Revised Basic Pension of Rs. (Rupees).

2. The Rate of Basic Family Pension has been revised to Rs. (Rupees) w.c.f. He/She is already drawing Basic Family Pension of Rs. (Rupees).

3. The amount of Death cum Retirement Gratuity has also been revised to Rs. He/She has already received DCRG of Rs. which may be adjusted from the revised amount of DCRG. So, the pensioner will get the balance amount of Rs. (Rupees). The outstanding Govt. dues, if any, may be adjusted at your level.

4. The pensionary benefits have been revised on provisional basis in view of the change in Basic Pay/Dearness Relief.

5. The Arrear of Pension, if any, may be disbursed to him/her at an early date after making adjustment of the payments of the Pension/Relief already made to the pensioner.

6. The Dearness Relief is admissible as per Punjab Govt. Rates for pensioners.

7. An entry in this regard has been made in the Service Book.
