Aadhaar obviates the need for producing multiple documents to prove one's identity. The provisions of section 7 of Amended Aadhaar Act and Regulations under the Act have come into effect from 25/07/2019 for the schemes funded out of Consolidated Fund of State.
3. In pursuance of Section 7 of (TARGETED DELIVERY OF FINANCIAL AND OTHER SUBSIDIES, BENEFITS AND SERVICES) ACT, 2016 (18 of 2016) and followed by The Aadhaar and Other Laws (Amendment) Act, 2019 the words "Consolidated Fund of State" has been inserted in Section 7 of Aadhaar Act.
4. Keeping in view the above said amendment, it is desired that all Punjab Government Departments passing on the subsidies, benefits and services to the beneficiaries for which the expenditure is met from the Consolidated Funds of State, need to issue a Notification in pursuance of provisions of Section 7 of Principal Aadhaar Act, 2016 (18 of 2016) and The Aadhaar and Other Laws (Amendment) Act, 2019.
5. It is, therefore requested that requisite notification on the above said matter (a sample of notification is annexed) is issued within one month from the issue of this letter and the same may be intimated to this office. Since the matter is extremely urgent the same be taken up on priority.

Besides above, individual(s) desirous of getting any of the above services and not yet enrolled for Aadhaar is hereby required to make application for Aadhaar enrolment, in case she or he is entitled to obtain Aadhaar as per provision of section 3 of the said Aadhaar Act, 2016 and The Aadhaar and Other Laws (Amendment) Act, 2019 and such individual may visit any Aadhaar Enrolment Centres (list available at WWW. UIDAI.GOV.IN) to get enrolled for Aadhaar.
