Sir/Madam,

I am directed to refer to this department Letter No. 3/72/2003-3FPPC/7280, Dated 12.12.2006, which was amended vide this department Letter no 3/72/2003-3FPPC/639 dated 25.05.2011 regarding the subject cited above and to say that under sub.Para (2) of Para 2 letter dated 25.05.2011, it has been provided that Government Employees will have to make contribution of 10% of Basic Pay+DA and the Government will make equal matching contribution.

2 The Government of Punjab has decided to enhance its monthly matching contribution from 10% to 14% of Basic Pay+ DA for its employees covered under the New Pension Scheme.

3 Sub-Para 2 of the above cited letter dated 25/05/2011 is therefore, substituted as under :

In tier 1 "The monthly contribution would be 10% of the Basic Pay+DA to be paid by the employees and 14% of the Basic Pay+DA would be paid by the Punjab Government as matching contribution."

Sub: **Extension of benefits of 'Retirement Gratuity and Death Gratuity' to the Punjab Government employees covered by New Defined Contributory Pension Scheme (known as NPS).**

Sir/Madam,

I have been directed to state that the Government of Punjab has decided to extend the benefit of Retirement Gratuity and Death Gratuity to its employees covered under the New Pension Scheme on the terms and conditions as per Rules 6.16, 6.16AA, 6.16-B and 6.16-C of Punjab Civil Services Rules Volume-II in so far as they relate to Death-cum-Retirement-Gratuity.

2. These orders shall be applicable to all those Punjab Government employees, who joined government service on or after 01.01.2004 and are covered by New Pension Scheme and shall be applicable w.e.f. 01.01.2004.

3. The Pension Sanctioning Authorities shall suo motto take up the cases of employees who have been covered under New Pension Scheme and since stand retired or expired with the Accountant General Punjab for the grant of benefit of Retirement Gratuity and Death Gratuity, as the case may be, after adopting due procedure as per Punjab Civil Services Rules, Volume II.

4. Necessary notification to amend the Punjab Civil Services Rules shall be issued in due course of time.


