Implementation of orders passed by the Hon'ble Punjab and Haryana High Court in terms of order dated 20.5.2013 passed by the Hon'ble Punjab and Haryana High Court in CWP No. 16446 of 2010 titled as Jaswinder Singh Bedi and Others v/s. State of Punjab and Others.

Sir / Madam,

The Department of Finance issued instructions vide letter No. 5/138/2009-3FP1/870 dated 20.6.2019 whereby the orders passed by the Hon'ble Punjab and Haryana High Court, Chandigarh in all CWPs in terms of orders dated 20.5.2013 in CWP No. 16446 of 2010 titled as Jaswinder Singh Bedi and Others v/s. State of Punjab and Others were implemented in letter and spirit alongwith arrears of 38 months prior to the date of filing of the respective writ petitions.

2. Further, in compliance of order dated 17.10.2019 of Hon'ble Punjab and Haryana High Court in COCP No. 3075 of 2015 in CWP No. 16446 of 2010, the Department of Finance, vide advice dated 31.10.2019, decided to release balance of consequential benefits in view of instructions dated 3.11.2006 to the petitioners in these cases.

3. Now the matter has again been considered in the Department of Finance and it has been decided that the decision for the release of all consequential benefits in view of instructions dated 3.11.2006 shall be applicable to all the petitioners in the cases which have been decided by the Hon'ble Punjab and Haryana High Court in terms of orders dated 20.5.2013 in CWP No. 16446 of 2010.

4. All the Administrative Departments are advised to implement the above instructions meticulously.
