- i) facilities, support and sponsorships to artists and writers with disability to pursue their interests and talents;
- ii) making art accessible to persons with disabilities;
- iii) facilitating participation in dancing and art classes;
- iv) redesigning courses in cultural and arts subjects to enable participation and access for persons with disabilities."
