

## Pre-Matric Scholarship Scheme For SC Students (CSS)

- \* Students of 9<sup>th</sup> and 10<sup>th</sup> Class are eligible
- \* Scholarship Amount Rs. 3000/- per student per year
- Parents Income Limit 2.50 Lacs
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Caste Certificate, Income Certificate, Domicile Certificate

## Pre-Matric Scholarship Scheme For OBC Students (CSS)

- \* Students of 1<sup>st</sup> To 10<sup>th</sup> Class are eligible
- \* Scholarship Amount Rs. 1500/- per student per year
- Parents Income Limit 2.50 Lacs
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Caste Certificate, Income Certificate, Domicile Certificate

### **Dr. Hargobind Khurana Scholarship Scheme (SSS)**

- Students who obtain 90 % and above marks in Matric are Eligible
- Students of only Government and Adarsh Schools are Eligible.
- Scholarship Amount Rs. 3000 per month for 2 years .
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File

### **General Scholarship Scheme (SSS)**

- Rs. 1,000/- once for Three Boys and Three Girls who got First Three positions in 5<sup>th</sup> Class at Block Level
- Rs. 1500/- once for Three Boys and Three Girls who got First Three positions in 8<sup>th</sup> Class at Block Level
- It is not caste based scheme
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File

## **Unclean Occupation Scholarship Scheme**

- Applicable to Students of First to Tenth Class
- Rs. **3000/-** per student per Year , FOR HOSTELLER-7000/- per year
- Not income based
- The students whose parents are Tanners, Flayers; and Waste pickers etc. are eligible for scholarship
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Domicile

## **55 -Award to SC Sports Students (6-12 Classes)**

- Only SC students of Punjab Domicile eligible
- Kabbadi, Kho-kho, Athletics (High Jump, Long Jump, 100 mts. Sprint, 400 mts Sprint), Gymnastic are covered in this scheme
- Rs. 500/- once (6<sup>th</sup> to 8<sup>th</sup> Class ) Rs. 750/- once (9<sup>th</sup> to 10<sup>th</sup> Class)  
Rs. 1000/- once (11<sup>th</sup> to 12<sup>th</sup> Class)
- 3 Boys and 3 Girls are eligible who got 1<sup>st</sup> three position at Block Level.
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Caste Certificate



## Post Matric Scholarship Scheme For SC Students (CSS)

- Parent's Income should not exceed Rs.2.50 lac per annum
- The student should not be getting any other scholarship
- 75% attendance must in current year
- Maintenance Allowance Rs. 2500 yearly and Rs. 4000 yearly for Hostellers plus reimbursement of fee and funds
- Pass Percentage of renewal beneficiaries should be at least 50% Failed Institute is illegible.
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Caste Certificate, Income Certificate, Domicile Certificate

## Post Matric Scholarship Scheme for OBC Students

- Parent's income should not exceed Rs. 1.50 lac per annum
- The student should not be getting any other scholarship
- 75% attendance must in current year
- Student must score 60% or above in matric
- Maintenance Allowance Rs. 160 per month plus reimbursement of fee and funds
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Caste Certificate, Income Certificate, Domicile Certificate

## Scheme of Up-gradation of Merit of SC Students

- 100% central assistance for arranging remedial classes for SC students for students of IXth to XII classes
- Aimed at providing coaching for competitive examinations like for Engineering and Medical
- The coaching should start from 9<sup>th</sup> and continue till 12<sup>th</sup>
- Rs. 25000 per student per year (Rs. 15000 to student and rest to principal and tutors as honorarium)
- Students from 2-3 districts with highest SC population, which are identified as Educationally Backward Districts are eligible
- District SBS Nagar, Muktsar and Ferozepur covered in this scheme  
Maximum 70 students can apply in this scheme.
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Caste Certificate, Domicile Certificate

### **Pre-Matric Scholarship For Minorities (CSS)**

- \* Students from 1<sup>st</sup> to 10<sup>th</sup> Class are Eligible with marks 50% or more
- \* Sikh, Muslim, Christian, Buddhist, Parsi and Jain religions considered
- \* For 1<sup>st</sup> to 5<sup>th</sup> Rs. 1000 per annum, for 6<sup>th</sup> to 10<sup>th</sup> Rs1000 per annum (Tuition fee+admission fee max upto Rs4000)

•Parents' Income Limit 1.00 Lacs

•Documents Required :-

•Aadhar card, Bank Account Pass Book PDF File, Caste Certificate, Income Certificate, Domicile Certificate

### **Post Matric Scholarship For Minorities (CSS)**

- \* Students from 11<sup>th</sup> & 12<sup>th</sup> Class are Eligible

\* Sikh, Muslim, Christian, Buddhist, Parsi and Jain religions considered

\* Rs 2300 per annum (Tuition fee+admission fee max upto Rs7000)

•Parents's Income Limit 2.00 Lacs

•Documents Required :-

•Aadhar card, Bank Account Pass Book PDF File, Caste Certificate, Income Certificate, Domicile Certificate



### N.M.M.S (National Merit-cum-Means Scholarship) (CSS)

- Merit scholarship is awarded to students who qualify the competitive test conducted in 8<sup>th</sup> class by SCERT
- The scholarship is for four years from 9<sup>th</sup> to 12<sup>th</sup> class
- The parents' income limit Rs.1.5 lac per annum
- Scholarship amount Rs. 12000 per annum
- Documents Required :-
  - Aadhar card, Bank Account Pass Book PDF File, Income Certificate, Domicile Certificate

### **Pre-Matric Scholarship Scheme for Students with Disabilities**

- For students of 9<sup>th</sup> and 10<sup>th</sup> students
- Income limit is 2.5 lac per annum
- Rs. 7000 per annum
- Scheme run by Social Security Department
- Students who claim scholarship under this scheme can not apply for pre-metric SC scheme
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Disability Certificate, Income Certificate, Domicile Certificate

### **Post Matric Scholarship Scheme for Students with Disabilities**

- Rs. 8100 per annum
- Income limit is 2.5 lac per annum
- Documents Required :-
- Aadhar card, Bank Account Pass Book PDF File, Disability Certificate, Income Certificate, Domicile Certificate
- For above schemes disability allowance is also given as under
- Visually impaired- Rs. 4000, Hearing impaired Rs. 2000, Physically disabled Rs. 2000, intellectual disability-Rs. 4000, all other types Rs. 2000



### Scholarship Scheme For Wards of Registered Labourers (Being Run By Labour Department)

- The labourer should be working in registered establishment as per Punjab Labour Welfare Act 1965
- If student fails in a class he/she will not be eligible to claim scholarship
- The student can avail another scholarship simultaneously along with scheme
- For students of 1<sup>st</sup> to 12<sup>th</sup> standard
- Registered Labourers are beneficiaries in this scheme
- Scholarship amount ranges from Rs. 3000 to Rs. 25000

### **Attendance Scholarship for SC Girls**

- Parents should not Income Tax payee
- Attendance of 75% or above required
- The student should be domicile of the Punjab state
- Scholarship amount Rs. 500 per annum

### **Attendance Scholarship for EWC and BC Girls**

- Income limit Rs. 1.00 lac per annum
- Attendance of 75% or above required
- The student should be domicile of the Punjab state
- Scholarship amount Rs. 500 per annum

NOTE - Ward can apply one scheme at one time.
