

These standards would cover expectations of the role of teachers at a different level of expertise/stage and the competencies required for that stage. Similarly, NEP also recognizes the role of mentors by asserting, "Teacher preparation is an activity that requires multidisciplinary perspectives and knowledge, formation of dispositions and values, and development of practice under the best mentors." National Council for Teacher Education (NCTE) is the premier organization looking after teacher education in the country. Implementing National Professional Standards for Teachers (NPST) and Mentoring Initiatives for School Education has been assigned to NCTE in NEP 2020. The participation of the teacher education professionals, academicians, teachers, teacher educators, educational administrators, expert organizations and other stakeholders is imperative for preparing the documents on NPST and Mentoring initiative. The National Professional Standards for Teachers (NPST) are a public statement of what constitutes teacher quality. They define the work of teachers and make explicit the elements of high-quality, effective teaching in 21st-century schools that will improve educational outcomes for students.

- 2. My NEP2020 portal on the NCTE website is an endeavour in this direction for broad participation of all stakeholders across the country through digital consultation. MyNEP2020 portal for the above is open from I April 2021 to 31 May 2021 for receiving comments/suggestions on NPST and mentoring willingness. This exercise has been envisaged to have a bottom-up approach for overall coherence in preparing the documents on teacher policy for sustainable and positive change in the Teacher Education Sector. Through this portal, NCTE also seeks to create a database of mentors willing to provide the necessary guidance to teachers/schools.

- 2. The exercise of digital consultation has been envisaged to invite suggestions/inputs/membership under the bottom-up approach for overall coherence in preparing the documents on teacher policy for sustainable and positive change in the Teacher Education Sector.
- 3.
