The instructions No. 11/61/99-2PP1/10219, dated 19.08.1999 issued by the Personnel Department on the above subject are amended as follows: -

<p>Para-9- "...In cases where no dependent member in the family of "War Hero" becomes eligible for appointment within the prescribed period of two years the request for appointment in such cases can be made within a period of 6 months after the dependent member in the family attains the age of eligibility for entry into Government Services provided that if such a dependent member of the family is pursuing higher education up to graduation level/vocational course which can improve their prospects, the request for appointment can be made within a period of 6 months from the date of completion of such studies/course or the age of 21 years whichever is earlier".</p>	<p>Para-9 (b) - "...In cases where the family members wish to reserve the Appointment for a dependent member who is currently a minor, then the same shall be conveyed in writing to the Government within a period of two years from the date of declaration of Battle Casualty. The request for appointment in such cases can be made within a period of 6 months after the dependent member in the family completes his or her studies or attains the age of 25 years, whichever is earlier .</p>

	Para 9 (c)
	Where due to reasons of extreme hardship, the wife of "War Hero" is constrained to immediately take up a Group D appointment in line with her educational qualifications, but upgrades her educational qualification within a period of Four Years of taking up such an appointment and becomes eligible for a Group C appointment, then such wife of a "War Hero" shall be entitled to a fresh appointment to a Group C post.

2. These orders shall be applicable with immediate effect.
