## Notification

Previously, the subject of English was being taught by Social Science Masters/Mistresses to the students of 6th to 10th classes studying in Government Middle, High and Senior Secondary Schools. But in view of academic interests, the Department allocated some separate posts of English Masters and Mistresses to teach exclusively subject of English to the students and such posts were included in the relevant Departmental Service Rules notified in the year of 2018. But, in the said Rules, the posts of English Masters and Mistresses have been allocated much lesser than that of the posts of Social Science Masters/Mistresses. Therefore, in order to remove such irrational distribution and to provide English Masters and Mistresses in adequate numbers in Government run schools so that study of students in the subject of English should not suffer adversely, it has been decided to re-distribute existing sanctioned posts of English Masters/Mistresses and Social Science Masters/Mistresses equally. Therefore, in exercise of the powers conferred by the proviso to Rule 3 read with Rule 2(d) of Punjab Educations (Teaching Cadre) Border Area Group 'C' Service Rules, 2018, (hereinafter referred to as 'said rules'), in Appendix 'A' of the 'said rules', the following entries with regard to number of posts shall stand modified as under:-

- (i) in Serial No. 3, in the main heading "Number of Posts", under sub headings 'Permanent' and 'Total', for the figures "826", the figures "2126", shall, respectively, be substituted; and
- (ii) in Serial No. 7, in the main heading "Number of Posts", under sub headings 'Permanent' and 'Total', for the figures "3426", the figures "2126", shall, respectively, be substituted.
- 2. The aforesaid modifications shall be effective from the date of publication of this notification in the Official Gazette.

Previously, the subject of English was being taught by Social Science Masters/Mistresses to the students of 6th to 10th classes studying in Government Middle, High and Senior Secondary Schools. Therefore, in exercise of the powers conferred by the proviso to Rule 3 read with Rule 2(d)of Punjab Educations (Teaching Cadre) Group 'C' Service Rules, 2018, the referred to as 'said rules', in Appendix 'A' of the 'said rules', the following entries with regard to number of posts shall stand modified as under:-

- (i) in Serial No. 3, in the main heading "Number of Posts", under sub headings 'Permanent' and 'Total', for the figures "2415", the figures "6131", shall, respectively, be substituted; and
- (ii) in Serial No. 7, in the main heading "Number of Posts", under sub headings 'Permanent' and 'Total', for the figures "9846", the figures "6130", shall, respectively, be substituated.
- 2. The aforesaid modifications shall be effective from the date of publication of this notification in the Official Gazette.
