

Subject: Generation of new PRANs of Education Department through IFMS.

Dear Sir.

Kindly refer to your DO letter No.DPI(SE)E-2/2021284156 dated 20<sup>th</sup> August, 2021 on the subject cited above.

2. The list of pending PRANs supplied by School Education Department has been sent to District Treasuries for clearance of pending cases. The District Treasury Offices have intimated that in most of the cases, the subscriber has opened new PRAN account directly on NSDL website due to which the new PRAN has not been mapped with Punjab Government. This office has issued instructions vide letter No.NPS/A-11/2021/250 dated 18/2/2021 to all departments to apply new PRAN through IFMS so that new PRAN could be mapped with Punjab Government automatically. The DDOs of School Education Department is not following these instructions due to which they are facing problem in drawing salary of new recruits. Now, NPS Office has mapped these PRANs with Punjab Government manually and now, concerned DDO can make salary in IFMS.

3. Besides above, DDOs have also not submitted hard copy of PRAN Registration application form along with requisite documents to Treasury Office in time due to which the Treasury Office is not able to verify and authorize the Registration Form to NSDL for issuance of new PRAN.

4. I shall be grateful if you direct all DDOs of School Education Departmenter to follow the above referred instructions of Finance Department in generation of new PRAN through IFMS and submit hard copy of Registration Form along with requisite documents to District Treasury Office in time so that there would be no delay in future.

## Subject: Online PRAN Generation for new subscribers covered under the New Pension Scheme (NPS) through Integrated Financial Management System (IFMS).

Sir/Madam,

These instructions are issued in supersession of instructions issued vide letter No.NPS/Pension Cell/Online PRAN Generation/2017/5934-38 dated 21.06.2017 titled" ਨਵੀਂ ਪੈਨਸ਼ਨ ਸਕੀਮ ਤਹਿਤ PRAN ਅਲਾਟਮੈਂਟ:- ਡੀ.ਡੀ.ਓਜ਼ ਵੱਲੋਂ ਆਨਲਾਈਨ ਪਰਾਨ ਅਪਲਾਈ ਕਰਨ ਸਬੰਧੀ" read with letter No. NPS/CMM/2018/4891 dated 03.10.2018 wherein the process of online PRAN generation for employees covered under NPS through National Securities Depository Ltd. (NSDL) and its verification through District Treasury Officers had been prescribed.

2. The Department of Finance has integrated its IFMS with NSDL software and the online PRAN can now be applied through IFMS only. The stepwise procedure shall be as follows: -

- The subscriber-employee (hereinafter, subscriber) shall deposit CSRF form alongwith the prescribed documents (Copy of appointment letter and joining report; Bank proof-Cancel cheque/Bank Pass Book copy; Address proof-Aadhar Card/Pan Card; Date of birth proof-Date of birth certificate/Matric Certificate) to his/her DDO.
- The subscriber shall also submit his/her photograph and signatures to his/her DDO alongwith the prescribed documents.
- iii) The DDO shall save the scanned copy of the photograph and signature of the subscriber on his / her official computer.
- iv) DDO shall login at website <u>https://ifms1.punjab.gov.ln/etreasury/</u> login by entering his user ID and password.

- The home page of the IFMS website, amongst interalia, displays V) "NPS".
- DDO shall select "PRAN registration" displayed under "NPS". vi)
- DDO shall fill the subscriber details as per the CSRF form submitted vli) by the subscriber-employee and upload the scanned photograph and signature of the subscriber.
- DDO shall cross verify the filled details of the subscriber and shall vill) submission an found correct. On submit details, if acknowledgement I.D. will be generated by the system.
- The DDO shall obtain a printout of the acknowledgement I.D. and ix) shall then forward the hard copy of CSRF form alongwith other prescribed documents and acknowledgement I.D. to District Treasury Officer for verification and authorization of the online form by District Treasury Officer.
- District Treasury Officer shall verify the details filled online by the X) DDO vis-a-vis the details filled in with CSRF alongwith prescribed documents and if found correct shall authorize the online form for PRAN generation.

The DTO, henceforth, will not verify and authorise those PRAN registration 3. where the DDO has filled the details directly on NSDL.

The need for re-entry of the subscriber data in the IFMS after its entry in 4. the NSDL website shall no longer remain in the new system since the details will be auto updated within different modules of the IFMS.

These instructions shall come into force with immediate effect. 5.
