**NOTIFICATION**

**No. G.S.R. 137/Const./Art.309/Amd.(1)/2021.-** In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules further to amend the Punjab State Elementary Education (Pre Primary School Teachers) Group 'C' Service Rules, 2020, namely:-

**RULES**

1. (1) These rules may be called the Punjab State Elementary Education (Pre Primary School Teachers) Group 'C' Service (First Amendment) Rules, 2021.  
(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Punjab State Elementary Education (Pre Primary School Teachers) Group 'C' Service Rules, 2020, in **Appendix 'B'**, against serial No. 1, under column No. 5, for the existing entries, the following shall be substituted, namely:-

"Should possess,-

(i) Senior Secondary School (Class Twelve) Certificate or Intermediate or its equivalent from a recognized Board or institution with at least 45% marks;

(ii) Diploma or Certificate in Nursery Teacher Education Programme of a duration of not less than one year recognized by the National Council for Teachers'

Education (NCTE),  
Government of India; and

(iii) should have three years  
experience either as a  
Education Provider,  
Education Volunteer,  
Education Guarantee  
Scheme Volunteer (EGSV),  
Alternative or Innovative  
Education Volunteer (AIEV),  
Special Training Resource  
Volunteer (STRV) or  
Inclusive Educational  
Volunteer (IEV) of  
Government run schools of  
the State of Punjab.
