

**Sub: Digital Village Program being executed by CSC e-Governance Services India Ltd. – regarding.**

Sir/ Madam,

I am directed to say that the Digital Village Pilot Project was initiated on 31<sup>st</sup> October 2018, covering 700 Gram Panchayats (GPs) with atleast one Gram Panchayat per District per State/UT. The project is being executed by CSC e-Governance Services India Ltd. with the total budget outlay of Rs. 98.324 Crores over duration of 3 years for reaching out services of – Health, Education, Financial Services, Skill Development, Solar panel powered street lights including Government to Citizens Services (G2C) and Business to Citizen (B2C) Services.

2. The Digital Village project is leveraging on two existing initiatives of Government of India - The BharatNet for broadband connectivity and the infrastructure and platform of Common Service Centres (CSCs) are being utilized for reaching out services to rural citizens. A Dashboard has also been developed for day to day monitoring of the project. ([www.digital-village.in](http://www.digital-village.in)).

3. Deliverables and Outcomes of the project are:

- (a) **Government to Citizens Services (G2C):** Such as e-District Services, SSDG (State Service Delivery Gateway) Services, Online registration for service selection board, online registration for public service commission, online registration for board of professional entrance examination, pan card services, new Aadhaar enrolment, updation and modification, etc,
- (b) **B2C Services:** Such as Mobile Recharge: Prepaid mobile recharge and Post-paid bill payment, DTH Recharge: DTH recharge, E Commerce: provide online market place to promote rural market products in India, Air Ticketing: Booking of flight ticket, Railway Ticketing: Booking of Railway ticket, e-Learning etc,
- (c) **Education Service: Courses offered under this project are as (i) Basic Computer Course (BCC), (ii) Tally – Kaushal Praman Patra (iii) Course on Computer Concepts (CCC),**
- (d) **Digital Health Services:** such as Tele Consultation, Veterinary Tele consultation.

- (e) **Financial Inclusion:** Conducting Financial Inclusion awareness programme to aware the provisioning of access to useful and affordable financial product and services to each individual of village. Such as Access to Bank account, Transactions, Insurance (Crop, Health, Life, vehicle, Cattle) pension scheme, banking KIOSK and special drive like cashless payment.
- (f) **LED Lights (8 Lights per village/GP):** To install solar panel powered street light in the villages. Solar panels with battery backup for ensuring always-on, low-powered base-stations.
- (g) **Skill Development services:** Focused skill development in mobile repairing, motor vehicle repairing mechanic, farming equipment repairing, electrician and Tally course. Automotive Service Technician, Handset Repair Engineer, Field Technician – Home Appliances

4. Expected Outcomes of the project:

- (i) Ease for citizens to access the Government schemes - More than 300 G2C and B2C services (such as online registration for Board of professional entrance examination, Pan Card Services, New Aadhaar enrolment, Updation and modification, Online registration for service selection board, Online registration for public service commission, online registration for Board of professional entrance examination, Mobile / DTH recharge Ticket Booking (Rail/Air), etc) will be available to citizens across India.
- (ii) Access of Financial Services through ICT
- (iii) Health Services - Health care service such as Tele-Health & Tele-Veterinary consultation will be available in the rural areas in which patient will consult with doctor.
- (iv) Literacy and Digital literacy – Digital Literacy courses such as (i) Basic Computer Course (BCC), (ii) Course on Computer Concept (CCC), (iii) Tally – Kaushal Praman Patra.
- (v) Skill development in (a) Automotive Technician, (b) Handset repairing, and (c) Field Technician (Home Appliances, Electrical Technician) will enhance the ability of the rural citizen and bring out their talent.

5. During the Video Conference held on 17-06-2022, it was decided that for the following courses enrollment has to be accelerated:

- (i) BCC Certificate Course (Basic Computer Course) (Target 98000 Achievement 15829)
- (ii) CCC Certificate Course (Course on Computer Concepts) (Target 49,000 Achievement 4129 )

6. Accordingly, it is requested to coordinate with their State/UT IT Department and Distt. Collectors/ DMs, where the Digital Village program is being implemented and ensure that adequate number of students register for the above free courses being offered through the Digital Village Project.
