The syllabus for the screening test as notified by the Government of Punjab vide No.G.S.R.37/Const.Art.309/Amd.(II)/2012 dated 24.7.2012 is as under:-

General knowledge in the subjects of Civics, Constitution of India, Indian History, Geography, General Science, Punjabi, English, History of Punjab and General Knowledge.

Out of the aforesaid subjects, at least ten questions shall be included from each subject in the screening test.

- ii) Fulfillment of the eligibility conditions i.e a confirmed hand, Has completed eight years of continued service, is under 54 years and is a Graduate from a recognized University vis-à-vis the cut-off date i.e 1<sup>st</sup> November, 2022 (Para 5 above may be referred)
- iii) Integrity, adverse remarks, departmental proceedings of the Applicant employee.
