MEMORANDUM FOR THE COUNCIL OF MINISTERS

Minister-in-charge School Education Minister, Punjab

Secretary-in-charge Principal Secretary, School Education, Punjab

Subject: Proposed amendments in the Punjab Educational (Teaching Cadre) Group-'C' Service Rules, 2018 and Punjab Educational (Teaching Cadre) Border Area Group-'C' Service Rules, 2018.

- 1.0 It is apprised that the service conditions of persons appointed to various services of the Department of School Education were being governed by the rules framed in the year of 1941, 1955, 1978, 1995 and 2004. With the passage of time, the old rules have become outdated. The Department of School Education then notified new rules for the Group 'C' cadre after these were approved by the Council of Ministers in the year 2018. A copy of these rules is placed at **Annexure** 'A' to the memorandum.
- 1.1 As per the Punjab Educational (Teaching Cadre) Group-'C' Service Rules, 2018 and Punjab Educational (Teaching Cadre) Border Area Group-'C' Service Rules, 2018, there was 25% quota for the promotion of master cadre posts, which was divided as following:
 - 24% from amongst eligible Primary Teachers (Irrespective of whatever nomenclature they are conferred)
 - 1% from Other Category of teachers.
- 1.2 The Department of School Education, Punjab had further amended Punjab Educational (Teaching Cadre) Group-'C' Service Rules, 2018 and Punjab Educational (Teaching Cadre) Border Area Group-'C' Service Rules, 2018 in the year 2020, in which 25% promotion quota had been divided further, which is as follows:-

- 20% from amongst eligible Primary Teachers (Irrespective of whatever nomenclature they are conferred);
- 4% from other category of teachers;
- 1% from amongst the non-teaching staff, working under control of Director.
- 1.3 The definition of 'Primary Teachers' in the existing rules reads as follow:-

"Primary Teachers means Elementary Teachers Training Teachers (ETT)/Junior Basic Training Teachers (JBT), Head Teacher (HT) and Center Head Teacher (CHT)' who fulfill the requisite qualification prescribed for various subjects of Masters and Mistresses by way of Promotion as mentioned in Appendix 'B' to these Rules and in addition to passing the Teachers Eligibility Test as per guidelines framed by the National Council of State Education, Government of India."

- 1.4 From the above it may be seen that the persons holding the posts of Elementary Teachers Training Teachers (ETT), Head Teacher (HT) and Center Head Teacher (CHT) are eligible for promotions against a 20% quota. So, there is a need to divide the 20% quota to the different nomenclatures of Primary Teachers i.e. ETT, HT and CHT. In order to avoid unnecessary litigation, which would take place if the quota for Primary Teachers was clubbed, it is proposed to split the 20% ratio into 15:4:1 amongst Elementary Teachers Training Teachers (ETT), Head Teacher (HT) and Center Head Teacher (CHT) respectively because the strength of ETT, HT and CHT is in descending order i.e. ETT-27441, HT-4331 and CHT-1045.
- 1.5 Accordingly, a draft notification has been prepared by the Department of School Education Punjab, which is attached at **Annexure 'B'** and **Annexure 'C'** to the memorandum. The details of the existing rules and the proposed amendment are also shown below:

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules further to amend the Punjab Educational (Teaching Cadre) Group 'C' Service Rules, 2018, namely: -

RULES

- These rules may be called the Punjab Educational (Teaching Cadre) Group 'C' Service (Third Amendment) Rules, 2023.
 - (2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
- 2. In the Punjab Educational (Teaching Cadre) Group 'C' Service Rules, 2018 (hereinafter referred to as 'said rules'), in appendix "B", in column 4 item (i) against Serial No.1 to 11 in column 1 shall be substituted, namely: -
 - "(4) (i) For the sentence "Twenty percent from amongst the eligible Primary Schools Teachers (irrespective of whatever nomenclature they are given)" the sentence and figure "Twenty percent from the amongst the eligible Primary Schools Teachers (Elementary Teachers Training Teachers- 15%, Head Teacher- 4%, Center Head Teacher- 1%)".
