However, this is against the Make In Punjab policy (Public Procurement order 2019, Letter No COS/PPO-2019/11726, Page no. 5, point No.9, issued by department of industries and commerce, Govt. of Punjab) which state that "the procuring entities shall endeavor to the see the eligibility conditions including Turnover, production capability and financial strength do not result in unreasonable exclusion of local supplier who would otherwise be eligible, beyond what is essential quality or creditworthiness of the supplier" In Addition to it, as per the CVC Guidelines for PQ (Pre-Qualification Criteria) Notification No. 12-02-1-CTE-6 "Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be 30% of the Estimated cost" and GOI India Guidelines issued from time to time to bring Efficiency, Economy, and Accountability in Public Procurement System. OEM Turnover Criteria in the aforementioned Tender is around 160 times of the estimate Tender value of Interactive flat panel which is unreasonably high. So, we request you to consider granting preference to Make in Punjab 	As per RFP.
