2. I am directed to inform that the General Elections to Municipal Councils Tarn Taran (District Tarn Taran), Dera Baba Nanak (District Gurdaspur) and Talwara (District Hoshiarpur) in the State are scheduled to be held on 2nd March, 2025. A copy of the Election Schedule is attached.

3. The process of elections has started and a large number of officers/officials are being put on election duty. In view of this, it is requested to ensure that Deputy Commissioners-Cum-District-Election Officers, Additional Deputy Commissioners (Dev.)-Cum-Additional District Election Officers, Sub Divisional Magistrates/ Tehsildars and other election-related officers directly involved in these elections may not be transferred without the consent of this Commission till the election process is completed by 3rd March, 2025.

4. As a number of officers /officials are also being put on election duty as RO's/ARO's/Presiding & Polling Officers, etc., general instructions may kindly be issued to all Departments for not carrying out any transfers in these Municipal Councils till the completion of the election process.

5. A copy of the instructions so issued, may kindly be endorsed to the Commission, for information.

NOTIFICATION

The 17th February, 2025

No. SEC/ME/SAM (CME)/2024/342.-The Department of Local Government, Punjab issued Notification No. 3/2/2019/MEO/EA/55, dated 22.11.2024 that the General Elections to elect the members of Municipal Councils/ Nagar Panchayats and Bye elections of certain wards of various Municipal Councils/ Nagar Panchayats mentioned in the notification were to be held by the end of December, 2024. Whereas, in pursuance to this notification the General elections to elect the members of 41 Municipal Councils/ Nagar Panchayats and Bye elections of 43 wards of various Municipal Councils/ Nagar Panchayats in the State were held on 21.12.2024.

2. Now, whereas the electoral rolls of Municipal Councils of Tarn Taran (District Tarn Taran), Dera Baba Nanak (District Gurdaspur) and Talwara (District Hoshiarpur) have been revised, with 01.01.2025 as the qualifying date, and the final publication of the electoral rolls has been done on 14.02.2025, therefore, in pursuance of the provisions contained in Section 35 of the Punjab State Election Commission Act, 1994, the State Election Commission hereby appoints the following dates for General Elections to elect the members of the Municipal Councils Tarn Taran (District Tarn Taran), Dera Baba

Nanak (District Gurdaspur) and Talwara (District Hoshiarpur) as per the following programme:

PROGRAMME

- (a) 17th February, 2025 (Monday) as the first date for filing of nominations.
(between 11 A.M. to 3 P.M.)
- (b) 20th February, 2025 (Thursday).
as the last date for filing nominations (upto 3 P.M.)
- (c) 21st February, 2025 (Friday).
as the date for the scrutiny of nominations;
- (d) 22nd February, 2025 (Saturday).
as the last date for withdrawal of nominations; (by 3 P.M.)
- (e) 02nd March, 2025 (Sunday).
as the date on which a poll shall, if necessary, be taken, and;
- (f) 03rd March, 2025 (Monday).
as the date by which the election process shall be completed.

Note: Counting of votes will take place on the same day after the completion of poll. Instructions on counting of votes will be issued separately.

3. In pursuance of the provisions of Section 57 of the Punjab State Election Commission Act, 1994, the State Election Commission hereby fixes poll hours from 7.00 A.M. to 4.00 P.M. during the poll on 02nd March, 2025 (Sunday).

4. With the issue of this Notification on 17.02.2025, the Model Code of Conduct comes into effect immediately within the revenue jurisdiction of the respective Municipal Councils where the elections are to be held, till the completion of the poll.
