Dear Sir/Madam

The Al Committee of the Hon'ble Supreme Court of India has framed guidelines for uploading all the legislation documents i.e. State Acts and Subordinate Legislations, including Rules, Regulations, notifications, circulars etc on India Code Website- www.indiacode.nic.in (copy enclosed). As per para No. 7 of the said guidelines, the Principal Secretaries of each Government Department shall designate a person responsible for forwarding to the Nodal Officer soft copies of all primary and secondary legislations, including Gazette Notifications as may be applicable to that department. It is further stated in the said para that as and when any new amendment is made, the amendments alongwith Gazette Notification shall also be forwarded to the Nodal Officer. As per para No. 9 of the said guidelines every Government department is required to furnish to the Nodal Officer all Primary Legislation and Secondary Legislation in soft copy in English as also the official language of the State and if there is any other predominant local language, in that language.

A meeting of the AI Committee of the Hon'ble Supreme Court of India was convened on 09.01.2025 through Video Conference and the same was attended, amongst others, by the Advocate General, Punjab, Additional Chief Secretary, Justice, L.R. and Principal Secretary and the Secretary, Printing and Stationery, Punjab. In the said meeting, it was Dominder Keines Cub Co.

decided that the State of Punjab shall upload the legislation documents i.e. State Acts and Subordinate Legislations, including Rules, Regulations, notifications, circulars etc in English language in one week on the India Code Website- www.indiacode.nic.in. It was also decided in the said meeting that the said legislation documents in Punjabi language will also be uploaded in due course. It may be mentioned here that many State Acts have already been uploaded on the said India Code Website, which may be viewed by the respective departments.

In view of the above, it is requested that soft copies of the legislation documents i.e. State Acts and Subordinate Legislations, including Rules, Regulations, notifications, circulars etc, which have not been uploaded on India Code Website, as applicable to your department, be sent to the undersigned within three days through the designated person of your department responsible for the same on this department's email i.d. lawsecypb@gmail.com as well as in pen drive so that the same may be transmitted to the Nodal Officer, Department of Printing and Stationery, Punjab for uploading on the India Code Website-www.indiacode.nic.in

GUIDELINES FRAMED BY THE HON'BLE AI COMMITTEE OF SUPREME COURT AND APPROVED BY HON'BLE THE CHIEF JUSTICE OF INDIA FOR UPLOADING OF PRIMARY AND SUB-ORDINATE LEGISLATIONS ON INDIA CODE WEBSITE- www.indiacode.nic.in:-

- and the Hon'ble Chief Justice of India indicating that translation of all judgements would have to be done at the earliest, one amongst the many areas that require immediate attention is as regards the availability of authenticated translated versions of primary and secondary legislation.
 - 2. The primary and secondary legislations have to be authenticated and certified to be true translations since it is these legislations that would be reproduced in the translated copies. The reproduction would have to be common and identical.
 - Primary Legislations would mean and include all ordinances, bills placed before each of the

legislatures, Law Commission Reports if any, relating to such legislation, Statement of objects and reasons, Legislative Debates regarding the sald legislation, the Act, amending acts relating to such act, repealing Act, repealed Acts, International Treaties, conventions and Declarations etc.,

- 4. Sub-ordinate Legislation would mean and include Rules, Regulations, Bye-laws, Notifications, Circulars, Government orders, amendments to each of them etc., issued in respect of or under each of the primary legislations, including repealed Acts, Rules etc., made under International Treaties, conventions and Declarations etc.,.
 - 5. It is required that both the Primary and secondary legislations are collated and uploaded on the <u>India</u>

 <u>Code Website- www.indiacode.nic.in</u> both in English and Vernacular, so that their reproduction in

the translated version is identical in all judgements and or that there is no discrepancy.

- 6. In order to achieve the above the Chief Secretary of each State would have to appoint a Nodal Officer and make available such staff as may be required for such nodal officer to perform his/her duties. Such appointment to be communicated to all the departments of the State Government indicating the powers and responsibilities of such nodal officer.
 - 7. The Principal Secretaries of each Government
 Department shall designate a person responsible for
 forwarding to the nodal officer soft copies of all
 primary and secondary legislations, including Gazette
 primary and secondary legislations, including Gazette
 Notifications as may be applicable to that Department.

 As and when any new amendment is made, the
 amendments along with Gazette Notification shall also
 be forwarded to the nodal officer.

- 8. The editor Karnataka State Gazette shall also forward soft copies of all Primary and Secondary Legislations which are published in the gazette to the nodal officer.
 - 9. The nodal officer shall if all Primary and Secondary Legislations are not available, be empowered to interact and call upon every Government Department to Furnish to him all Primary Legislation and Secondary Legislation in soft copy in English as also the official language of the State and if there is any other predominant local language, in that language;
 - number of Administrative Logins to India Code Usernames and Passwords to each such nodal officer
 as such nodal officer may require so as to enable
 such user to upload the Primary and Secondary
 legislations on the India Code website.
 - 11. The NIC to make provision for uploading all central enactments in all languages prescribed and

recognized under Schedule VIII of the Constitution of India and such other predominant local languages as may be requested by the nodal officer/s.

12. The nodal officer and his/her staff shall cause uploading of:

Central Enactments:

- 12.1. All translated Primary and Secondary legislations of the Central enactments, including their Gazette Notification.
- 12.2. For purposes of such uploading, the NIC shall provide a similar interface as that available for the English version of the central enactments so as to enable the Nodal Officer to upload the translated version in that particular format.
- 12.3. The detailed SOP on the manner of uploading of translated copies of central enactments to be provided by the NIC to each of the nodal officers.

State Enactments:

- 12.4. The NIC shall create a portal for creation of the web page for each State enactment which the nodal officer is required to upload, the final out put shall be in the same manner and have a look and feel as that already available for existing central enactments.
 - 12.5. The nodal officer and his/her staff shall cause uploading the English version of all Primary and Secondary Legislations of his/her state, including their Gazette Notification.
 - 12.6. The upload made shall be in a similar manner sections wise as, now done for central enactments. The Sections, Schedules, Annexures, Appendix, Forms, Act details etc., will have to be separately uploaded by the nodal officer and his/her team.
 - 12.7. The NIC shall make available a portal for uploading the translated version of the Primary

and Secondary Legislations as regards the State enactments.

- 12.8. The nodal officer and his/her team shall upload the translated version of the Primary and Secondary enactments in the official language of the State and if there is any other predominant local language in that language also, including their Gazette Notification.
- 13. The above activities to be completed on or before 20.11.2023.
