COUNSEL FOR THE PETITIONERS

CIVIL WRIT PETITION UNDER ARTICLE 226 OF THE CONSTITUTION OF INDIA SEEKING THE FOLLOWING RELIEFS:

- i) issue a Writ in the nature of Mandamus, summoning records of the case;
- ii) issue a writ in the nature of Mandamus directing the Respondents to grant the statutory pay scale of the petitioners as mandated in the 2018 Rules viz.

 10300-34800 + Grade Pay Rs. 4200/- from entry into service along with arrears and interest at 12% thereon;
- iii) issue a Writ in the nature of Mandamus directing the Respondents to take into account the statutory pay scale of Rs.10300-34800 + Grade Pay Rs. 4200/- with further pay revisions.
- iv) issue a Writ in the nature of Certiorari, quashing the instructions dated 21.10.2020 and 17.07.2020, Annexures and P-5 & P-6 respectively;

AND/OR

- v) Issue a Writ in the nature of Mandamus/Certiorari holding that instructions dated 17.07.2020, Annexure P-6, have no application in the recruitment of the petitioners;
- vi) issue a Writ in the nature of Certiorari quashing the impugned Order dated 31.03.2022 (Annexure P-9) to the extent it places the petitioners in the wrong pay scale of Rs. 29200/- (consolidated);
- vii) issue any other appropriate Writ, Order or Direction, as this Hon'ble Court may deem just and proper, keeping in view the peculiar facts and circumstances of the present case;
- viii) dispense with the service of advance notice upon the Respondents;
- ix) exempt the petitioners from filing the certified copies of the Annexures along with the present Civil Writ Petition and also allow the petitioners to place on record Photostat/dim/downloaded copies of few of the Annexures;

x) award the costs of the present Writ Petition in favour of the petitioners and against the Respondents.

RESPECTFULLY SHOWETH:

- 1. That the petitioners are the citizens of India and residents of various places in the State of Punjab and Haryana and are working as Elementary Trained Teachers (ETT) in Government Schools of Punjab and are entitled to invoke the extra ordinary Writ Jurisdiction of this Hon'ble Court under Articles 226 of the Constitution of by way of filling the instant Civil Writ Petition.
- 2. The facts in brief which gave right to the filing of the present writ petition are that the Respondent-Education Department vide its Advertisement dated 30.07.2021, has advertised 6635 posts of ETT teachers. The true translated copy of said Advertisement dated 30.07.2021 is annexed herewith as <u>ANNEXURE P-1</u>.
- 3. That the petitioners being eligible for the above said advertised posts of ETT have applied online for the same in the their respective categories and appeared for the written examination and Subsequently the petitioners were given appointment on the basis of their merit in their respective categories for the above mentioned post. The appointment letter of one of the petitioner is annexed herewith as ANNEXURE P-2. The list of the petitioners regarding their post, date of joining and place of joining in Education Department Punjab/Respondent is annexed herewith as ANNEXURE P-3.
- 4. That it is necessary to mention here that the posts in question are governed by "Punjab State Elementary Education (Teaching Cadre) Group C Service Rules, 2018" (herein after referred to as "2018 Rules"), published on dated 21.05.2018, and "(Teaching Cadre) Border Area Group C Service Rules, 2018" published on dated 21.05.2018 which are annexed herewith as ANNEXURE P-4 and ANNEXURE P4A and as per "Appendix A" of the afore-noted rules ETT teachers are entitled to pay scale of Rs.10300-34800+4200.
