I am directed to refer to this Department's letter of even number dated 15.10.2025 on the above-mentioned subject and to say that the Ministry of Social Justice and Empowerment (DoSJE), Government of India is organizing a high-level event to commemorate the 5th Anniversary of the Nasha Mukt Bharat Abhiyan (NMBA), scheduled to be held at Guru Nanak Dev University, Amritsar on 18th November, 2025.

- Multi-city outdoor media and outreach campaigns highlighting vulnerable groups, Nasha Mukt Champions (recovered addicts), and addiction professionals—facilitated by the Central Bureau of Communication (CBC), Ministry of Information & Broadcasting;
- Mass Pledge campaigns in educational institutions targeting 10 crore students;
- Music band performances at public locations by Central Universities, educational institutions, and schools; and
- Promotion of *Sports and Sporting Activities* among youth as an effective antidote to addiction.
- 3. In view of the above, it is once again requested to sensitize schools and educational institutions in your State/UTs, particularly those empanelled under the Pre-Matric and Post-Matric Scholarship Schemes, about this mega event and encourage their active participation in the campaign, including taking the *Mass Pledge*.

Standard Operating Procedure for Conducting Mass Pledge under the Nasha Mukt Bharat Abhiyaan

1. Objective


3. Campaign Period:
