Civil Writ Petition under Article 226/227 of the Constitution of India for issuance of appropriate writ, order or directions, especially writ in nature of mandamus directing the Respondents to consider the claim of the petitioners for extending them the benefit of judgment of Hon'ble High in case of "Saurabh Sharma and others Vs State of Punjab and others, CWP 15896 decided 13.09.2024 2023" on (ANNEXURE/P-5) and followed in many other similar matters including "CWP No. 22995 of 2024, Imran Hussain and others Vs State of Punjab and others" (ANNEXURE/P-6), decided on 14.10.2024, principal judgment has which further affirmed by the Hon'ble Division judgment/order Bench vide 10.12.2024 (ANNEXURE P-8), and further upheld by the Hon'ble Supreme Court vide order dated 20.01.2025 passed in "SLP (C) 1158/2025" (ANNEXURE/P-9) and reaffirmed vide order dated 20.03.2025 passed in "Review Petition No. 400 of

(ANNEXURE/P-10), consequently, grant them the benefit of Rs. 10300of scale regular pay 34800+4200 GP, as stipulated in the statutory Rules, "Punjab State Elementary Education (Teaching Cadre) Group C Service Rules, 2018 dated 21.05 2018, as amended from time to time and release all the due consequential benefits, as per their entitlement from the due date till the date of actual benefits, along with interest on as delayed payment at the rate of 12% per annum from the due date of their date of the entitlement till payments in their favour.

### AND/OR

Further issuance of Writ in the nature of Mandamus directing Respondents to decide the Legal Notice dated 02.06.2025 (Annexure P-7) by passing a reasoned and speaking order, in a time bound manner.

### AND/OR

Any other relief which this Hon'ble Court may deem fit and proper be passed in favour of the petitioner and against the respondents.

## **RESPECTFULLY SHOWETH: -**

- 1. That all the petitioners are presently working as ETT Teachers in various Primary/Elementary Schools in the State of Punjab, as mentioned in the cause title and all the Petitioners are residents of State of Punjab and thus, being citizens of India and they are competent to invoke the extra ordinary writ jurisdiction of this Hon'ble Court under Article 226/227 of Constitution of India.
- 2. That all the petitioners who were recruited against 5994
  ETT Cadre recruitment process in pursuance to an advertisement dated 12.10.2022, are presently working as
  ETT Teachers in various Government Primary/Elementary
  Schools in the State of Punjabi, as per the details mentioned in Memo of Parties.
- 3. That the State of Punjab/Education Department in order to regulate recruitment of the teachers in the ETT Cadre framed the statutory recruitment rules namely, "Punjab State Elementary Education (Teaching Cadre) Group C Service Rules, 2018" dated 21.05.2018, as amended from time to time. As per the Statutory Rules, the posts of ETT Teachers, carries a regular pay scale of Rs. 10300-34800-4200 G.P. and accordingly, a candidate who is appointed
