The undersigned is directed to refer to the concept note of Project Veer Gatha 5.0 and the timelines for various activities mentioned in it.

2. In this regard, it is observed that, till now, the details of SNOs and DNOs have not been received from a few of the States/UTs, which indicates that the school-level activities have not been started in all the States/UTs. To ensure maximum participation and provide adequate preparation time for schools, the timeline for various activities have been revised. The revised timeline for Project Veer Gatha 5.0 may be seen at **Annexure**.

3. The concerned State Nodal Officers (SNOs) are requested to communicate this information to all District Nodal Officers and Schools in their jurisdiction. Also, the Nodal Officer of CBSE is requested to communicate the information to the CBSE affiliated Schools for maximum participation.

Latest by 5 th September, 2025	Education Departments of States / UTs and all the Education Boards will thereafter issue notices to their respective schools for promoting / conducting the Veer Gatha 5.0 project.
