

NOTIFICATION

The 30th March, 2026

No. G.S.R. 28/Const./Art.309/Amd.(3)/2026.- In exercise of the powers conferred by the proviso to article 309 read with clause (3) of article 187 of the Constitution of India, and all other powers enabling him in this behalf, the Governor of Punjab, after consultation with the Speaker of the Punjab Vidhan Sabha, in so far as such consultation is necessary under the aforesaid provisions, is pleased to make the following rules further to amend the Punjab Civil Services Rules, Volume-II, namely:-

RULES

1. (1) These rules may be called the Punjab Civil Services (Amendment) Rules, Volume-II, 2026.

(2) They shall come into force at once.

2. In the Punjab Civil Services Rules, Volume-II, in rule 6.17, in sub-rule (3), in clause (e), at the end, for the sign '.', the sign ':' shall be substituted and thereafter, the following proviso shall be added, namely:-

"Provided that where a deceased Government employee or pensioner is not survived by a widow or widower or a child or parents eligible for family pension, or if the widow or widower, children and parents of the Government employee or pensioner cease to be eligible for family pension, the family pension at the rate specified in sub-rule (1) or rule 6.17-A, as the case may be, shall be payable to the dependent siblings suffering from a mental or physical disability, of the Government employee or pensioner for life if the siblings

were wholly dependent upon the Government employee or pensioner immediately before his or her death. The other terms and conditions for grant of family pension in this case shall remain the same as those applicable in the case of disabled son or daughter."
