No. G.S.R. 165/Const./Art.309/Amd.(2)/2025.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules, further to amend the Punjab Educational Service (Vocational) Group 'B' Service Rules, 2018, namely:-

RULES

1. (1) These rules may be called the Punjab Educational Service (Vocational) Group 'B' Service (Second Amendment) Rules, 2025.
(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Punjab Educational Service (Vocational) Group B Service Rules, 2018 (hereinafter referred to as the said rules), rule 7 shall be omitted.

RULES
