CIVIL WRIT PETITION under Article 226/227 of the Constitution of India for issuance of appropriate writ, order or direction especially a writ in the nature of Mandamus directing the respondents to release the arrears of pay anomaly for the period from 01.11.2011 to 06.10.2014, so as to graciously accord the Petitioners salary and service benefits commensurate with, and not lesser than, those extended to his junior counterparts, in the interest of justice.

AND

Further for issuance of a writ in nature of Mandamus directing the respondents to decide the legal notice dated 13.12.2025 (Annexure P-1), to release the arrears of pay anomaly for the period from 01.11.2011 to 06.10.2014 with applicable interest of 18% per Amum from the date the anomaly arose, i.e., 01.11.2011, till the date of actual payment the interest of justice.

RESPECTFULLY SHOWETH: -

1. That the petitioners are the permanent resident of the above-mentioned address of State of Punjab and therefore, the petitioner being the resident of the State of Punjab is entitled to invoke the extra ordinary writ jurisdiction of this Hon'ble Court by way of filing the present petition.
2. That the present writ petition is being filed under Articles 226/227 of the Constitution of India for issuance of an appropriate writ, order or direction, especially in the nature of Mandamus, directing the respondents to release the arrears arising out of pay anomaly along with interest, which have been illegally withheld by the respondents despite removal of anomaly.
3. That the petitioners are regular Government employees working as Elementary Trained Teachers (E.T.T.) in various Government Schools under the Education Department, Government of Punjab. The petitioners were duly selected and appointed during the period from the year 2006 to 2008 pursuant to a valid advertisement and proper selection process. Since their appointment, the petitioners have been rendering continuous, uninterrupted, and satisfactory service without any break or adverse entry.
4. That the Government of Punjab, Department of Finance issued Circular Letter No. 5/10/09-5FPI/665 dated 05.10.2011, whereby the pay scales of teaching staff were revised. As per the said circular, E.T.T. Teachers were placed in the pay scale of ₹10300-34800 + ₹4600 Grade Pay, with
