**No. G.S.R. 198/Const./Art.309/Amid.(3)/2025.-** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules, further to amend the **Punjab State Elementary Education (Administrative Cadre) Group 'B' Service Rules, 2018**, namely:-

**RULES**

1. (1) These rules may be called the Punjab State Elementary Education (Administrative Cadre) Group 'B' Service (Second Amendment) Rules, 2025.  
(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Punjab State Elementary Education (Administrative Cadre) Group 'B' Service Rules, 2018 (hereinafter referred to as the said rules), for rule 7, the following rule shall be substituted, namely:-

**"7. Departmental Examination.-** Every person appointed to the Service, unless he has already done so, has to qualify the Departmental Examination, as may be specified by the Government, from time to time."
3. In the said rules, in rule 10, for the word "State", the words "respective district" shall be substituted.
4. In the said rules, in Appendix 'A',-
