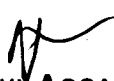

CIVIL WRIT PETITION UNDER ARTICLE 226 OF THE CONSTITUTION OF INDIA PRAYING FOR THE ISSUANCE OF A WRIT OF MANDAMUS DIRECTING THE RESPONDENTS TO FIX, NOTIFY AND GRANT THE PAY-SCALE TO ASSOCIATE TEACHERS AND ASSOCIATE PRE-PRIMARY TEACHERS APPOINTED UNDER THE POLICY FOR WELFARE OF AD-HOC, CONTRACTUAL, TEMPORARY TEACHERS (NATION BUILDERS) AND OTHER EMPLOYEES IN SCHOOL EDUCATION DEPARTMENT DATED 07.10.2022, ANNEXURE P-1, IN TERMS OF CLAUSE 7(e) OF THE SAID POLICY, INSTEAD OF PAYING THEM A FIXED CONSOLIDATED AMOUNT OF Rs. 23,500/- PER MONTH, WHICH IS BEING PAID TO THE ASSOCIATE TEACHERS AND Rs. 18,000/- PER MONTH, WHICH IS BEING PAID TO THE ASSOCIATE PRE-PRIMARY TEACHERS;

AND

FOR THE ISSUANCE OF A WRIT OF MANDAMUS DIRECTING THE RESPONDENTS TO FIX, NOTIFY AND GRANT THE PAY SCALE TO THE PETITIONERS UNDER THE POLICY FOR WELFARE OF AD-HOC, CONTRACTUAL, TEMPORARY TEACHERS (NATION BUILDERS) AND OTHER EMPLOYEES IN SCHOOL EDUCATION DEPARTMENT DATED 07.10.2022, ANNEXURE P-1, KEEPING IN VIEW PRECEDING STATE ACTION TOWARDS PRE-PRIMARY SCHOOL TEACHERS UNDER THE PUNJAB STATE ELEMENTARY EDUCATION (PRE-PRIMARY SCHOOL TEACHERS) GROUP 'C' SERVICE RULES, 2020 OR TEACHERS RECRUITED UNDER THE SARVA SHIKSHA ABHIYAN (SSA);

AND

FOR THE ISSUANCE OF ISSUE A WRIT OF MANDAMUS OR ANY OTHER APPROPRIATE WRIT, ORDER OR DIRECTION DIRECTING THE RESPONDENTS TO PAY THE PETITIONERS' SALARY, PAY AND ALLOWANCES IN TERMS OF THE NOTIFIED PAY-SCALE WITH EFFECT FROM THE DATE OF APPOINTMENT, ALONG WITH ALL CONSEQUENTIAL BENEFITS, INCLUDING ARREARS, ALONG WITH INTEREST AT THE RATE

OF 12 (TWELVE) PERCENT PER ANNUM FROM THE DATE OF
APPOINTMENT.

RESPECTFULLY SHOWETH:

1. That the Petitioners are residents of the State of Punjab and citizens of India. The Petitioners are therefore entitled to invoke the extraordinary writ jurisdiction of this Hon'ble Court under **Articles 226** of the **Constitution of India**.

2. That the Petitioners, in the instant writ petition, are aggrieved by the inaction of the Respondents in not fixing, notifying and granting the pay scale of Associate Teachers and Associate Pre-Primary Teachers appointed under the **Policy for Welfare of Ad-hoc, Contractual, Temporary Teachers (Nation Builders) and other Employees in School Education Department**, dated 07.10.2022.

Despite the clear mandate contained in **Clause 7(e)** of the Policy dated 07.10.2022 requiring determination of salary, pay and allowances by the Department of Finance, Government of Punjab, the Associate Pre-Primary Teachers are being paid only a fixed consolidated amount of Rs. 18,000/- per month and Associate Teacher are being paid Rs. 23,500/- per month as salary.

3. That the brief facts leading to the filing of the present writ petition are as under:

(a) The Government of Punjab, with a view to provide stability and welfare to ad-hoc, contractual and temporary employees working in the School Education Department, formulated the **Policy for Welfare of Ad-hoc, Contractual, Temporary Teachers (Nation Builders) and other Employees in School Education Department**, dated 07.10.2022.

The same envisages placement of eligible teachers and employees into a '*special cadre*' so as to ensure continuity of service and stability in the functioning of Government schools.
